

PRINCIPLES FOR THE PROTECTION OF PERSONAL DATA

The company Starland Holding a.s. processes your personal data in the necessary extent

- (i) in accordance with valid laws in the area of personal data protection (Act No. 18/2018 Coll. on the protection of personal data as changed and amended)
- (ii) in accordance with the General regulation of the European Union (EU) on the protection of personal data (Regulation of the European Parliament and the EU Council No. 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC).

As the protection of personal data is important for us, our employees, clients, suppliers, commercial partners and other concerned persons we have taken all necessary measures so that our employees, clients, suppliers, our commercial partners and other concerned persons could rely on securing the maximum protection of their personal data on our part.

Your personal data are processed by our company exclusively in the extent in which you have provided us with these data by filling out the contact form on the website www.starlandholding.sk or www.parkcity.sk.

Personal data are processed exclusively for the purpose of enabling the answer to your interest on our offer presented on our websites or on printed advertising/information materials about our company.

Personal data are collected and subsequently processed exclusively for the purpose of registration of our commercial partners and potential clients and in case of your consent to marketing purposes or to updating of our offer.

We process your personal data within the purpose to which they have been collected and in line with valid security standards. We process your personal data only for the necessary time needed for reaching the purpose to which they have been collected. When we no longer need personal data for fulfilling the respective purpose which has authorised us to their original collecting and processing we will either cancel the data or provide their anonymization.

If it is necessary and/or required by valid legal norms we always require from the concerned person a revocable consent to collecting and processing personal data.

During the whole period of processing your personal data we guarantee the accuracy and within reasonable limits also the updating of personal data and ensure that the concerned persons have information about personal data stored about them and that inaccurate information be corrected. You have anytime the right to receive a confirmation about the existence of your personal data and to know their content and origin, to analyse their curiosity or to require their integration, updating or adjustment.

All our employees, commercial partners and suppliers have to keep confidentiality and must not use provided data to other purposes than to purposes to which you have provided the data and to which we have made them accessible. Personal data must not be provided to other external parties, except for cases in which it is necessary for fulfilling legal and contractual obligations of our company. The access to personal data is authorised only to persons which have to process the data within their tasks or other obligations. Digital data are protected by firewalls, passwords and other technical means. All personal data are stored in locked premises which are protected by managing the physical access to them (entry only by using an entrance card and entering a password).

We regularly and with due care analyse the risks in the area of personal data protection connected with their collecting, processing and storing in order to guarantee the maximum protection of personal data provided by you.
